



Palliative Care

Palliative care is an *interdisciplinary* care delivery system designed to anticipate, prevent, and manage:

- physical,
- psychological,
- social, and
- spiritual suffering

to optimize quality of life for patients, their families and caregivers.

5 key pointers to consider in providing care

- Pointer #1 – Communication is the Key
- Pointer #2 – Symptom Management is essential

Pointer #1

Communication is the Key

- Have you thought about your own Advance Directives?
- Are you comfortable discussing loss of function with a client?
- How might you bring up these subjects with a client who needs CRT, due to loss of function?



Pointer #2

Symptom Management is Essential

- Impact of Disease Modulating Therapies (DMTs) on management of persons with MS
- How can CRT assist in management of persons with Advanced MS?
- What ‘symptoms’ can CRT help address?



Pointer #3

Support for caregivers is important.

- What are some of the challenges in providing care to clients with a progressive condition?
 - Health Care providers?
 - Formal and Informal Caregivers?
- What's the impact of losing the ability to walk for a person with MS?
 - How might this loss impact a family member and /or care giver?
- How might CRT assist a care giver?

Pointer #4

Palliative Care when combined with care of patients with MS will benefit patients, families and the MS Care Team.

MS Patients and Families


- Unhurried, often revisited, discussions about a person's wishes and exploration of 'what matters most' is most helpful BEFORE a health crisis is so important.

MS Care Team

- Participation in an *interdisciplinary* team willing to honestly discuss CARE as well as drug therapies, helps manage emotions and expectations.

Palliative Care and CRT


Domains

CRT Impact


- Offers options for mobility and comfort in different positions.
